
Office fee: Non NCDA members: \$20 per horse/rider combination.



<u>SHOW LOCATION Directions</u>: Tomora Training Center, 11000 US Highway 34 Bypass, Greeley, CO 80634. From I-25, take the Highway 34 exit East approximately7 miles to the Highway 34 Bypass. Continue on Bypass approximately 1 (one) mile. Tomora Training Center is on the South side of the road, enter at drive and head back West towards Main barns.

<u>SHOW Parking:</u> Trailers park in lots to the South of the Main Indoor Arena/Barn. Please be considerate of your fellow exhibitors. Those with Day Stalls may park as directed by Tomora Training Center. Be sure to keep your area cleaned up from trash and manure. Wheelbarrows at TTC are available for use.

Vehicles without trailers – may park along the fencing to the East of the barn and main parking lot. Please do NOT park alongside the Trailers.

<u>Concessions:</u> Morning Beverages, water, some snacks.

<u>SHOW Arenas</u>: Tomora Training Center: Outdoor warmup with sand footing. Classes in Indoor arena with sand-mix footing. Small arena 20 meters x40 meters, large arena 20 meters x 60 meters.

All riders *must wear* ASTM/SEI protective head-gear while mounted (per USEF General Rules 801). Please use tack and attire appropriate to the discipline and level being ridden. If in doubt, please check with the Show Office.

Please note the following information from the USEF Rulebook, Chapter 13

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

8. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
